## MEMBER RENTAL AGREEMENT

This agreement is made between the above stated Renter and Somerset Volunteer Fire & Rescue Company No. 1, hereinafter known as The Fire Company. Equipment issued for function will be checked after each use. The Renter agrees to pay for all equipment that is lost, broken or damaged. The Renter also agrees to pay damage to the facilities. It is also agreed that The Fire Company shall not be responsible for any property the Renter, the Renter's guests, or any other persons invited to the facilities attendance or clean up for this function. Should the Renter fail to make a scheduled payment the function may be cancelled by The Fire Company and the deposit may be forfeited. Also, in the event the Renter fails to hold the function, or cancels the date secured by this agreement, the deposit may be forfeited to The Fire Company for insufficient cancellation time.

The Renter agrees to clean the facilities and all parking areas used to the satisfaction of The Fire Company, unless the Renter entered into the contracted agreement to have The Fire Company perform these duties. The Renter further agrees to dispose of all garbage in the proper containers and to recycle any recyclable materials. Failure to meet any or all of these garbage disposal/recycle requirements may result in forfeiture of clean-up/security deposit to The Fire Company.

This lease is granted upon the expressed conditions, however, that in case said Renter fails to observe the regulations governing the facilities, or carry out all of the covenants and conditions of this lease, or in case The Fire Company shall deems objectionable or improper any conduct on the part of the Renter or occupants, The Fire Company shall have full power and authority to re-enter and have full possession of said facilities within one hour's notice.

All rentals must terminate no later than 11:00 pm (EST/EDT), and the premises be vacated at that time. No alcoholic beverages will be served to anyone under legal age for alcoholic beverage consumption in the State of New Jersey. No one allowed behind the Bar at anytime under the age of 21. The Renter agrees to hold harmless The Fire Company from any and all incidents and liabilities arising from said function attributed to any alcoholic beverage consumption while in attendance.

No cooking utensils, dishes, cups, glasses, flatware, or linens are to be supplied by The Fire Company.

No one is allowed in the bay area where the fire trucks are housed at any time.

No tacks, staples or tape of any kind, etc. is allowed on the walls or ceiling.
